

# Consulate For The Federation of Saint Kitts and Nevis

#### REQUIRED DOCUMENTS AND INTRUCTIONS TO APPLY FOR RENEWAL PASSPORT

### On the Passport Application Form, you will have to complete the following:

- 1. Sections 1, 2, 3 and 6 must be completed by all applicants.
- 2. Sections 4 and 5 to be completed where applicable.
- 3. Section 7 is to be completed by Parent or Legal Guardian of an applicant under age 16.
- 4. Section 8 is to be completed by an applicant age 16 and over.
- 5. Section 9 I to be completed by the recommender.

### For Persons Under Age 16

- 1. Completed Application Form (A child in the age group of 8 to 15 is required to submit three signature samples on an unlined sheet of paper).
- 2. Two (2) passport sized colour photos (1.7" x 1.38" (45mm x 35mm)).
- 3. Applicant **Original** or **Notarized** copy of Birth Certificate.
- 4. Applicant **Original** or **Notarized** copy of Saint Christopher and Nevis Certificate of Citizenship (*if applicable*).
- 5. Old Passport.
- 6. **Fee: CDN** One hundred and Thirty-Six dollars (*CDN* \$136.00), payable to the *Consulate* of St. Kitts and Nevis.
- 7. Any other document as may be required.

### For Persons Age 16 and Over

- 1. Completed Application Form.
- 2. Two (2) passport size colour photos (1.7" x 1.38" (45mm x 35mm)).
- 3. Applicant **Original** or **Notarized** copy of Birth Certificate.
- 4. Applicant **Original** or **Notarized** copy of Saint Christopher and Nevis Certificate of Citizenship (*if applicable*).
- 5. **Original** Police Record (if applicable).
- 6. **Original** or **Notarized** copy of Marriage Certificate (*if applicable*).
- 7. Old Passport.
- 8. **Fee: CDN** One hundred and Eighty-Six dollars (*CDN* \$186.00), payable to the *Consulate* of St. Kitts and Nevis.
- 9. Any other document as may be required.

### **Citizens by Investment**

- 1. Completed Application Form (A child in the age group of 8 to 15 is required to submit three signature samples on an unlined sheet of paper).
- 2. Two (2) passport sized colour photos (1.77" x 1.38" (45mm x 35mm)).
- 3. Applicant **Original** or **Notarized** copy of Birth Certificate (*translated to English* if not in *English*).
- 4. Applicant **Original** or **Notarized** copy of Saint Christopher and Nevis Certificate of Registration.
- 5. **Original** Police Record (if applicable).

- 6. **Original** or **Notarized** copy of Marriage Certificate (if applicable) and translated to English if not in English.
- 7. Old Passport.
- 8. **Fee: CDN** Three hundred and Eight-Six dollars (*CDN* \$386.00), payable to the *Consulate of St. Kitts and Nevis*.
- 9. Any other document as may be required.

CASH, CREDIT CARD, INTERAC or PERSONAL CHEQUES NOT ACCEPTED AS PAYMENT

### **Photographs:**

Two (2) copies of a recent photograph of the applicant must be included with the application. These photographs should be taken full face, without earrings (for male), without a hat on a neutral solid background. Black and white photographs are not acceptable. The size of the photographs is 1.77" x 1.38"(45mm x 35mm). The recommender (guarantor) is also required to endorse the reverse side of one copy of the photographs with the words "I certify that this is a true likeness of the applicant Mr./Mrs./Miss......."and add his/her signature.

### **Recommender** (Guarantor):

**Section 9:** Should be completed by the person verifying the declaration of the applicant. The recommender (*guaranto*r) must know the applicant for at least two (2) years with a professional stamp and add stamp in the area that says, 'Original Stamp'. Recommender (guarantor) should be a Justice of the Peace, Notary Public, Minister of Religion, Medical or Legal Practitioner, Senior Civil Servant, Senior Bank Official, Gazetted Police Officer, or any person of similar standing **PERSONALLY ACQUAINTED** with the applicant. Members of the Immediate Family are not eligible.
